September 22, 2020

APPROVAL OF THE MEETING AGENDA (Resolution #4297)

It was moved by Mrs. Charters and seconded by Mr. Wilt to approve the agenda as revised.

The board members present unanimously approved the motion. President of the board, Mr. Lane, declared the motion carried.

LEGISLATIVE LIAISON REPORT

Mr. Peck reviewed "The Link" to the board members to review. The September issue was provided in the board packets.

• COVID-19 immunity bill sent to governor

The Ohio House of Representatives and Senate through a conference committee ironed out differences between the chambers on House Bill (HB) 606, a bill that provides K-12 schools and others immunity from civil liability due to the exposure of COVID-19. The legislation that passed the House at the end of May was amended in the Senate before passage in June. The House on Sept. 1 reconvened and voted not to concur with the Senate amendments to its bill, and a conference committee was subsequently convened. Members of the committee were able to expeditiously work and favorably approve a bill that both chambers could support. Two changes to the bill were made during the conference committee. The first change moved the expiration date of the liability protections from Dec. 31, 2020, to Sept. 30, 2021, and the second change removed the bill's emergency clause. The House accepted the conference committee report on HB 606 by a vote of 62-30 and the Senate followed suit by a vote of 22-8.

• Bi-partisan education bill that extends previous flexibilities receives hearing

Sens. Teresa Fedor (D-Toledo) and Nathan Manning (R-North Ridgeville) co-sponsored Senate Bill (SB) 358 that would extend certain provisions of HB 197 and HB 164. The bill would prohibit the Ohio Department of Education (ODE) from issuing state report cards for both the 2020-21 and 2021-22 school years. Sanctions from state report cards would also be frozen. The eligibility list for EdChoice vouchers would remain at the 2019-20 list and no new vouchers would be issued except for siblings and other exceptions. School districts could also choose to use final course grades for the 2020-21 school year if end-of-course exams were unable to be administered. Additionally, the bill eliminates state-required assessments and requires ODE to apply for a waiver from administering the federally required assessments.

On Sept. 2, the bill received its first hearing in the Senate Education Committee. Fedor made the following remarks during sponsor testimony, "Without the extension of these provisions, the uncertain learning conditions in the 2020-21 school year will be even more stressful for teachers, students, and families. Missing school has produced serious gaps in student learning. Coupled with the normal summer losses, teachers will need to focus on getting students back on track." Manning during his testimony noted that while the bill freezes state report card sanctions it also doesn't allow the removal of schools under academic distress commission control and made the following remarks, "We hope that we can continue working with the committee to work on ways where those three school districts in academic distress do have a pathway out." Senate Education Committee Chair **Peggy Lehner** indicated that she expects the bill to be expedited, and additional hearings would be scheduled soon.

LEGISLATIVE LIAISON REPORT (Cont.)

• Ohio Department of Health order allows all sports to continue

Gov. **Mike DeWine** announced that all contact and non-contact sports may continue through an Ohio Department of Health (ODH) order that provides mandatory practice, competition, and spectator requirements. The order applies to youth, collegiate, amateur, club, and professional sports. DeWine made the following remarks about the order, "Look at the plan we have and try the best you can to execute that because we believe that gives your kids the best chance of being able to play a season."

The ODH order requires daily symptom assessments, maintaining at least six-feet social distancing from individuals, and strict compliance with the face mask order. The face mask requirements allow exceptions for players who are on the field or court of play and for coaches and officials during games and practices, among other exceptions. Additionally, schools are allowed to move fall sports to the spring. Lt. Gov. **Jon Husted** provided additional remarks regarding the enforcement of the order, "Coaches have an expanded role as educators and leaders in this particular year. Everyone involved must be accountable. In addition to the health department, the OHSAA will hold schools, athletes, and parents accountable. They will have site inspectors at contests to ensure that the rules are being followed. The failure to comply with these rules can result in forfeits of athletics contests and disqualification from competition for the season."

Recently introduced legislation

- SB 350 introduced by Sen. **Andrew O. Brenner** (R-Powell), to prohibit school districts from providing transit passes for public transportation to students enrolled in grades kindergarten through eight for the 2020-21 school year and to require the Ohio Department of Education to deduct district payments for non-compliance.
- SB 352 introduced by Roegner, to repeal a provision of law that modified municipal income tax employer withholding rules for COVID-19-related work-from-home employees.

FINANCIAL REPORTS

Mrs. Meyer commended Beth, Rhonda, and Amanda for submitting items to the auditor while she was off recovering from the accident. The audit did not have to be put "on hold."

Mrs. Meyer reviewed the monthly reports with the board.
