#### GREAT OAKS ITCD REPORT

Mr. Lane disseminated the highlights of the November 8, 2017 Board of Directors' Meeting to board members for their review and reported the following:

- Fallon Research Report Paul Fallon of Fallon Research and Communications conducted a survey of over 400 homes in the Great Oaks districts to better understand how they are viewed, perceived value and support among constituents. He reported the following findings to the Great Oaks Board:
  - o 56% said workforce preparation is the more practical role for school
  - o 92% agreed that with increasing college costs, it is essential to provide high school students with advance technical and skills training
  - o 88% are aware of Great Oaks and 77% had a favorable opinion; in 2007, 87% were aware and 65% had a favorable opinion
  - o Great Oaks is well known and liked, and it is often seen as an alternative to college, not a pathway
- Job Placement Great Oaks currently has 66 students on job placement. For a senior to be on job placement they must have 95% attendance, 3.0 GPA in their Great Oaks courses and the recommendation from their Career Technical Instructor, and be on track to graduate.

## LEGISLATIVE LIAISON REPORT

Mrs. Gausman disseminated "The Link" to board members for their review and reported the following:

- Contact your Ohio House member and oppose voucher expansion Reach out to your Ohio House member and express opposition to House Bill (HB) 200, school choice legislation that would expand publicly funded vouchers statewide. HB 200 creates the Ohio Opportunity Scholarship (voucher) Program, a new statewide program allowing K-12 students to use a voucher to attend private schools. The legislation would directly fund the vouchers from the state instead of it being deducted from the resident school district. This will drain state resources that would best be utilized in Ohio's public schools where the vast majority of Ohio's students choose to be educated.
- Recently introduced legislation:
  - o HB 418 requires a public or chartered nonpublic school to transmit a student's records within five business days when the student transfers to another school
  - o HB 426 prohibits an employee of a school or institution of higher education who is not in a position of authority from engaging in sexual conduct with certain students

- HB 428 regarding student religious expression and to entitle the act "Ohio Student Religious Liberties Act of 2018"
- o SB 226 provides for a permanent three-day sales tax holiday each August during which sales of clothing and school supplies are exempt from sales and use tax
- Kids PAC Kids PAC is your political action committee (PAC). PACs are accounts from which political campaign contributions can be made and is a way to focus attention on OSBA's legislative agenda and to support lawmakers who believe in our goals. Giving to Kids PAC helps you get more out of your own political contributions. It "pools" smaller, individual donations into a more sizable contribution that often garners more attention from the political candidate. Contributions can be made by personal check or cash up to \$100. By law, school district and corporate checks cannot be accepted. - OSBA delegate assembly makes changes to legislative platform for 2018 The OSBA delegate assembly met at Capital Conference in November and approved a number of amendments and added a plank to the association's legislative platform. OSBA's platform conveys where the association stands on issues impacting public education.
  - o Delegates approved amendments supporting legislation that:
    - Repeals Amended Substitute HB 70 that created academic distress commissions with the power to interfere with governance by locally elected boards of education
    - Requires every piece of legislation introduced by the Ohio General Assembly to follow a consistent and thorough deliberative process allowing ample opportunity for public review and comment, with the rules established by the Ohio Constitution
    - Limits the requirement for public school districts to provide transportation to only those days are are synchronous with the district-adopted calendar
    - Fully funds districts for the cost of transportation of special education students, foster children and homeless students who receive transportation accommodations

### LEGISLATIVE LIAISON REPORT (Cont.)

- Enables student discipline to be dealt with individually in a way that is appropriate for a student's age, gender, mental health condition, emotional development and special education needs and appropriately protects the school's educational environment
- Enhances the homestead exemption program to provide financial assistance for senior citizens
- Delegates approved amendments opposing legislation that:
  - Once having been introduced, is later attached to a different and/or larger piece of legislation before is has been thoroughly and properly vetted and heard by both chambers of the General Assembly
  - Increases a school district's potential liability or increases the damages potentially assessed
